I understand the risks of my child's participation in these activities, and knowing and appreciating these risks, I voluntarily choose to allow my child to participate, assuming all risks of injury due to my child's participation. Therefore, I do hereby waive, release, covenant not to sue and forever discharge to the fullest extent permitted by law, the General Board of the Church of the Nazarene, its employees and volunteers and all related or connectional organizations, officers, agents, employees, representatives, successors and assigns from any and all responsibilities, claims, expenses, personal injury, wrongful death or liability for injuries or damages of any kind arising from my child's participation in any of such activities or arising out of participation in the church's General Assembly in June, 2009. I do also hereby indemnify, release and hold harmless, to the fullest extent provided by the law, all of those mentioned and others acting upon their behalf from any responsibility or liability for any injury, damage or death to my child, including those caused by the negligent act of omission of any of those mentioned or others acting on their behalf or in any way arising out of or connected with my child's participation in such activities. The provisions of the Permission to Participate will continue in full force and effect even after the termination of such activities, whether by agreement, by operation of law or otherwise. If any provision of this Permission to Participate is held invalid or unenforceable by any court of competent jurisdiction, the remaining provisions will continue to be fully effective. This Permission to Participate contains the entire agreement between the parties
